### ASSURANCE STATEMENT

#### Introduction

DNV Business Assurance Co. Ltd. Taiwan ('DNV') has been commissioned by the management of CHIMEI CORPORATION ('ChiMei' or 'the Company') to carry out an assurance engagement on the Company's 2020 Greenhouse Gas Scope 3 Emissions Report ('the Report') against the "Corporate Value Chain (Scope 3) Accounting and Reporting Standard," and "Guidance for Calculating Scope 3 Emissions" developed by WRI & WBCSD. The verification was conducted in accordance with ISO 14066:2011, ISO 14065:2013 and ISO 14064-3:2006 and the DNV Protocol for Verification of Sustainability Reporting (VeriSustain ®).

The management of CHIMEI CORPORATION is responsible for the collection, analysis, aggregation and presentation of information within the Report. Our responsibility in performing this work is to the management of CHIMEI CORPORATION only and in accordance with terms of reference agreed with the Company. The management of CHIMEI CORPORATION are the intended users of this statement. We consent to the release of this assurance statement by CHIMEI CORPORATION in order to satisfy the terms of CDP disclosure requirements but without accepting or assuming any responsibility or liability on our part to CDP or to any other party who may have access to this assurance statement or our assurance report. The assurance engagement is based on the assumption that the data and information provided to us is complete and true.

#### Scope of Assurance

The scope of work agreed upon with CHIMEI CORPORATION is the Scope 3 CO<sub>2</sub>e emissions (with specified/limited list of sources of Scope 3 emissions) included the following:

#### **Verification Methodology**

The verification was conducted by DNV from May 25, 2021, by suitably qualified and experienced professionals, in accordance with ISO 14066:2011, ISO 14065:2013, ISO 14064-3:2006 and DNV Protocol VeriSustain.

The Report has been evaluated against the following criteria:

- In accordance with the "Corporate Value Chain (Scope 3) Accounting and Reporting Standard," and "Guidance for Calculating Scope 3 Emissions" developed by WRI & WBCSD;
- Adherence to principles set out in DNV's Protocol VeriSustain.

During the assurance engagement, we have taken a risk-based approach, meaning that we concentrated our verification efforts more on the high material data flow. We have challenged the statements and claims made in the Report and assessed the robustness of the underlying data management flow and controls. In doing so, we have:

- Examined and reviewed documents, data and other information made available to DNV by CHIMEI CORPORATION;
- Visited the head-office and the related operation offices located in Taiwan;
- Performed sample-based checks of the emissions dataset and consolidation process;
- Review of procedures for collection of activity data and emission factor and calculations including routines for data quality management.

#### **Conclusions**

It is DNV's opinion, in accordance with limited assurance, we conclude that no systematic errors were detected which causes us to believe that the specified data presented in the Report is not reliable in accordance with the "Corporate Value Chain (Scope 3) Accounting and Reporting Standard," and "Guidance for Calculating Scope 3 Emissions".
